FOR GOLDEN STATE SERIES ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIRE FILLIES, TWO YEARS OLD By subscription of \$100 each if made on or before Wednesday, September 19, 2012 or by payment of \$1,000 by Saturday, October 6 or by supplementary nomination of \$25,000 at time of entry. (Supplementary nominees do not have to pay the starting fee. Supplementary nominees are automatically eligible to all future Golden State Series Stakes, subject only to regular nomination and starting fees.) All horses to pay \$750 to pass the entry box and \$3,000 to start with \$250,000 guaranteed of which \$137,500 to the winner, \$47,500 to second, \$27,500 to third, \$15,000 to fourth, \$7,500 to fifth, \$5,000 to sixth, \$5,000 to seventh and \$5,000 to eighth. Weight: 120 lbs. Starters to be named through the entry box by the closing time of entries. Horses with the highest earnings at time of entry will be preferred. A trophy will be presented to the winning owner.
