Weights: Three year olds 117 lbs.; older 124 lbs. Horses which have finished 2nd or 3rd in a non-claiming race in at least one of their last 3 starts preferred. Second preference will be given to non-starters for a claiming price. Third preference will be given to horses which have finished 2nd or 3rd for a claiming price in one of their last 2 starts. Should the race not be divided and the number of entries exceed fourteen (14) preference will be determined by the above described conditions. (Winners are not eligible and will forfeit their nomination fee). All fees will be refunded to horses which fail to draw into this race. A Trophy will be presented to the winning owner.
