## Sunshine Millions/California Cup On Saturday, January 25

The five stakes races on the Sunshine Millions/California Cup card for Saturday, January 25, restricted to horses bred or sired in California, drew a total of 113 nominations.

The richest races will be the \$250,000 Cal Cup Derby and the \$250,000 Cal Cup Turf Classic. The Derby's 18 nominations include grade I winner Tamarando and stakes winners California Chrome and Aotearoa. The Turf Classic's 27 nominations include multiple graded stakes winner Summer Hit.



The 26 nominations for the \$200,000 Cal Cup Oaks for three-year-old fillies include multiple stakes winner Swiss Lake Yodeler, while the \$125,000 Cal Cup Sprint includes stakes winner Cyclometer and graded stakes winner Rousing Sermon among its 16 nominees.

The \$125,000 Sunshine Millions Filly and Mare Turf Sprint's 26 nominations include multiple stakes winner Warren's Veneda.

Sprint as the 5-2 favorite in his second start following an 18-month layoff.

Both stallions stand at Ballena Vista Farm.

Undeclared at distances of six furlongs or less, Secret Circle has never finished worse than second in nine career starts. He earned \$859,800 for his two victories in as many starts in 2013 and increased his lifetime bankroll to almost \$1.9 million.

Points Offthebench is the second California-bred Eclipse Award finalist for Benchmark, whose three-year-old Idiot Proof was among the 2007 finalists in the male sprinter category.

Ballena Vista sire Tribal Rule also has a close connection to the 2013 Eclipse Awards as his full sister Common Hope is the dam of the Two-Year-Old Male finalist, Shared Belief.

## Favorable Tax Provisions Expire; Extender Bill Introduced

During 2013, horse owners, breeders and businesses enjoyed a number of favorable tax provisions that have now reverted to lower levels or expired. Over 60 tax provisions expired, some applied to all businesses, including the horse industry, and one was specifically applicable to owners of race horses.

While the Tax Extender Act of 2013 has been introduced to extend these various tax provisions, such legislation will not be passed quickly or easily. Opposition has already been expressed by some. In addition, any such extension is affected by the stomach in Congress to deal with broader, fundamental tax reform involving much of the current tax code.

For the last few years, the so-called Section 179 business expense deduction was set at \$500,000. This meant that anyone in the horse business, or any business for that matter, could immediately depreciate up to \$500,000 of the cost of any investment in business assets, including horses. The deduction was reduced dollar-for-dollar once investment in all one's business activities hit \$2 million. It applied to horses and other depreciable property purchased and placed in service in the horse business.

This provision was not extended by Congress and has now reverted to \$25,000 for 2014.

Anyone in a business could also write-off up to 50 percent of new property purchased and placed in service in 2013, including assets used in the horse business, such as horses and other equipment. This was known as "bonus depreciation." It was restricted to new assets, which meant that the first use of the horse or other property had to begin with the taxpayer.

This was also not extended and has expired completely for 2014.

Finally, from 2009 through 2013 all race horses could be depreciated over three years, regardless of when they were placed in service. This provision was passed in 2008 through the efforts of Minority Leader Mitch McConnell (R-KY). The change, which eliminated the seven-year depreciation period for race horses and made all race horses eligible for three-year depreciation, expired at the end of 2013. Beginning in 2014, the pre-2009 rules will have to be used, meaning owners will have to decide whether to place a race horse in service at the end of its yearling year and depreciate it over seven years or wait until it is over 2 (24 months and a day after foaling) and depreciate it over three years.

The tax extender bill would extend over 60 expired tax provisions, including:

- Reinstating the expense deduction at \$500,000;
- Reinstating bonus depreciation at 50 percent; and
- Reinstating the depreciation of race horses at three years.

Whether these provisions are extended depends on whether Congress can come to grips with a real tax reform package. If it can, the various expired tax provisions will be dealt with in that package. If it can't, it's more likely that a simple tax extender bill will be passed. But as mentioned earlier, even that will not be done easily or quickly.

In addition to the tax extender bill, a stand-alone bill has been introduced by Congressman Andy Barr (R-KY), the Race Horse Cost Recovery Act (H.R. 2212), which would make permanent the ability to depreciate all race horses over three years regardless of their age when placed in service. —<http://www.horsecouncil.org>

## California-Bred Flashback:

### Final Fling

On January 13, 2008, Final Fling, a daughter of Bertrando, won the grade III, \$100,000 Santa Ysabel Stakes for three-year-old fillies at Santa Anita Park, with Grace Anatomy second and Kazamira third in a field of six. Final Fling was trained by Jeff Mullins and ridden by Joe Talamo. She ran the 1 1/16 miles in 1:41.96 on a fast track and won by 1 1/4 lengths at odds of 11-1. Final Fling was the eighth of 12 foals out of the Java Gold mare Lily La Belle, who also foaled the stakes-placed Doc Wild. The Santa Ysabel was Final Fling's second win in four starts. She also was third in the grade I Santa Anita Oaks, was second Melair Stakes and finished her career with two wins in nine starts and earnings of \$181,204. Final Fling was bred by William Peeples, was foaled at Loeb Ranch in Riverside and was owned by Michael House.





## Thoroughbred Placement Study Released

A report released today by Retired Racehorse Training Project (RRTP) is the first nationwide study of how Thoroughbred ex-racehorses are transitioned into second careers. It is based on a survey conducted in late 2013 titled Exploring the Bridge To Second Careers in which owners of 4,200 ex-racehorses from 47 states and Canada responded to 23 questions.

"The public believes that racing owners dump their retiring horses into auctions and that a lucky few get rescued and adopted," said RRTP president Stuart Pittman.

"Our survey tells a different story. Most of these horses were not rescued. They were sold or donated through networks of people both inside and outside of racing who work very hard to transition these animals."

- 34 percent of these horses were acquired directly from racing owners.
- 31 percent were acquired from non-racing private owners.
- 13.5 percent were acquired from non-profit placement or rescue organizations, although that share increased from 11 percent to 19 percent over the last ten years.
- 9 percent were acquired from professional training or sales businesses.
- 2.3 percent of horses came through auctions.

The survey also revealed that prices for horses increased with training, but are still far below what it costs to transition racehorses to new careers.

- The average adoption fee at nonprofit placement organizations was \$1001 (22 percent were free). These organizations were most likely to have horse protection terms in contracts.
- Horses acquired through racing owners were purchased for an average price of \$1,265 (30 percent were given away).
- Horses sold through private non-racing owners had an average price of \$2,618 not including the 19 percent that were free.
- Horses sold through professional training or sales businesses had an average sale price of \$4,646, not including the 4 percent given away.
- The average price at public auction was \$839.

The survey respondents identified the sport of eventing as their primary riding discipline most often (37 percent). Hunter/jumper was second at 27 percent, dressage third at 13 percent, and then trails and recreation (English) at 9 percent.

The following conclusions are taken from the full survey report.

- Racehorses are placed in second careers with long-term owners through a marketplace that lacks networks and forums through which the sellers, trainers, and buyers can find one another.
- Prices and adoption fees are depressed to a level that makes subsidies for those providing transition services essential until demand rises significantly.
- The financial incentive to retire horses sound from racing does not exist until increased demand raises prices for retiring horses.

Retired Racehorse Training Project (RRTP) will respond to the results of this study with a major expansion of its work in 2014, including:

- A second Thoroughbred Makeover and National Symposium at Pimlico Racecourse on October 4 and 5 that will include more horses, more trainers, and more racing stables;
- Contracts for professional services that will re-launch its heavily trafficked web site, develop partnerships with racing and riding institutions, explore the feasibility of a publishing venture; and
- Compile, print, and distribute the first state-by-state resource directory for Thoroughbred placement.

## Decongestant Added To Banned List

The Association of Racing Commissioners International has added a nasal decongestant already banned by the World Anti-Doping Agency and many U.S. sports leagues to its list of prohibited substances, the association announced on January 9.

The substance, methylhexanamine, is an organic compound that has a stimulant side effect and could once be found in a number of over-the-counter supplements before the FDA ruled that it was potentially dangerous last year and could no longer be marketed.—*continued at [www.bloodhorse.com](http://www.bloodhorse.com), By Matt Hegarty*
