Weight: 123 lbs.. Non-winners of \$60,000 twice allowed 2 lbs., such a race allowed 4 lbs., non-winners of a race other than maiden, claiming or starter allowed 6 lbs., a race other than claiming or starter allowed 8 lbs.. Starteres to be named through the entry box by closing time of entries. A trophy will be presented to the winning owner.
